## SAGIPER WARRANTY

### Warranty Coverage

For products purchased hereunder Sagiper North America Inc. and Sagiper Produção e Comercialização de Perfis em PVC (hereafter referred to as Sagiper) warrants the original owner they are free from manufacturing defects subject to the conditions below. Warranty against excessive board material discoloration, loss of film adhesion, bubbling, or excessive board warping where installed in Canada or continental United States of America, as follows:

- SAGIWALL boards for interior applications: Lifetime
- SAGIWALL boards for exterior applications: 15 years from the date of purchase
- SAGIREV boards for interior applications: Lifetime
- SAGIREV boards for exterior applications: 15 years from the date of purchase

Should any products be determined by Sagiper to have manufacturing defects, at the option of Sagiper such products will be replaced or repaired, and then returned to the owner, via Sagiper North America Inc.. Products will be delivered either to Sagiper NA facility or the Sagiper retailer/distributor where the products were originally purchased. The degree of discoloration/colour fading will be evaluated by Sagiper, who will be the sole judge of what is considered reasonable or excessive discoloration.

From time to time Sagiper manufacturers new products, patterns, and colours, revises products, and occasionally discontinues products. Sagiper cannot guarantee replacement Sagiper materials will be an exact match of the original installed materials. At the discretion of Sagiper, equivalent replacement products may be supplied.

If any of the exclusions, disclaimers, or limitations are prohibited by law in a jurisdiction, they may be severed from this warranty without affecting the validity of the balance of the provisions.

### Limitations to Warranty

Sagiper does not warranty damage arising from improper handling, installation, or maintenance, not in compliance with Sagiper guidelines. All installation instructions must be followed without exception. Use of pneumatic nailers will void the warranty. If SAGIREV panels are installed on an exterior wall applications warranty is void.

Sagiper does not warranty damage arising from abuse, exposure to harmful chemicals, or exposure to localized heat sources such as fireplaces, barbecues, or space heaters.

Sagiper does not warranty damage arising from extreme forces such as fire, earthquakes, storms, acts of nature, acts of war, and acts of terrorism.

Owner to submit warranty claim within thirty (30) days of discovery of product defect, or the warranty is void.

### Limitations to Liability

Sagiper will not be liable for any consequential, incidental, special, or indirect losses.
