ELIGIBILITY AND REQUIREMENTS

- Home must be primary residence, and homeowner must provide proof of ownership. Only one registration per household.

IMPORTANT PROGRAM INFORMATION

- Homeowner must provide receipts for the pre- and post-retrofit EnerGuide evaluations, as well as invoices and receipts for purchased products and the cost of the installation.
- All products must be purchased in Canada; online purchases are eligible only if ordered from an online distributor in Canada.
- Windows/doors must be on an eligible list (see reverse side).
- Maintain ENERGY STAR labels on products until after the post-retrofit evaluation.
- A new window unit can be inserted into the existing frame of an old window, but replacements of only the glass, sash or door without a frame are not eligible.

ELIGIBLE WINDOWS AND DOORS

Replace windows or sliding glass doors with ENERGY STAR3-certified models:

- U-Factor of 1.22 W/m²K or less OR
- Energy Rating ≥ 34

Replace windows or sliding glass doors with ENERGY STAR Most Efficient-certified models:

- U-Factor of 1.05 W/m²K or less OR
- Energy Rating ≥ 40

Replace hinged doors, with or without sidelites or transoms, with ENERGY STAR-certified models:

- U-Factor ≤ 1.22 W/m²K OR
- Energy Rating ≥ 34


